Legal Analysis of The Moral Outcry Petition

The Moral Outcry is not just a petition to the Supreme Court, but a public interest litigation strategy. It has been endorsed by major Pro-Life leaders in America such as Dr. Dobson of Family Talk, Dr. Alveda King, Father Frank Pavone of Priests for Life, Jeanne Mancini of March for Life, Kristan Hawkins of Students for Life, Tim Wildmon of American Family Association, and many more.

Justices Brett Kavanaugh and Justice Neil Gorsuch co-authored a book released in 2016 before they were nominated to our Highest Court. In their book, The Law of Judicial Precedent, one of the reasons for overturning a former Supreme Court decision is if the case has been met with “general dissatisfaction, protest, or severe criticism.” The Moral Outcry petition righteously identifies 5 legal reasons why *Roe v Wade* can be and should be overturned.


1. **Abortion is a Crime Against Humanity:** This occurs when the government withdraws legal protection from a class of human beings. The courts have done this in the past with their *Dred Scott* decision allowing slavery and *Plessy v. Ferguson*, legally approving segregation. Calling abortion a crime against humanity is justifiably a “severe criticism.”
2. **Safe Haven Law:** There are far better alternatives to abortion today than existed in 1973 or 1992, the last time the Supreme Court evaluated abortion. Today, in all 50 states, a woman may surrender a baby to a hospital, fire station, police station, etc. within a designated period of time. The Safe Haven Law protects the baby and the mother is relieved of all legal responsibility to care for the child. 3. **New Science:** Since 1973 when *Roe v Wade* was decided at the Supreme Court, we have new science that shows that life begins at conception, such as DNA and sonograms. When there are new developments in science and technology that add clarity to current laws, they should be applied.
4. **Abortion Hurts Women:** As a pastor, you may have experienced the grieving and healing process for women in your congregation who have had abortions in their past. The Moral Outcry Petition, although a movement, is not a pressure campaign on the court. Normally, Supreme Court Justices should not be swayed by public opinion. We desire that these Justices shall rule righteously, based on the constitution. However, the Law of Judicial Precedent allows “severe criticism” to be evaluated in reversing a Supreme Court decision. Therefore, every signature is actual evidence of severe criticism. The Justice Foundation has represented The Moral Outcry before The Supreme Court and will continue to do so until *Roe v. Wade* and its other abortion cases are overturned.
